ENTRY & ACCEPTANCES

Nomination of yearlings (first payment)

Horses to be entered when yearlings (subject to provision for "late entry" of two-year-olds) before 3pm, Tuesday 4 July 2023. Entry fee – \$440 (inc. GST).

Late Nominations

Late nomination fee of \$2,750 inc GST to be paid before 3pm, Tuesday 1 August 2023.

First Acceptance

First acceptance fee of \$605 inc GST to be paid before 3pm, Tuesday 3 October 2023.

Second Acceptance

Second acceptance fee of \$1,100 inc GST to be paid before 3pm, Tuesday 16 January 2024.

Late Entry of Two-Year-Olds

Entries of two-year-olds not qualified under the conditions may still be received up to 11am, Monday prior to race, on payment of a "late entry" fee of \$150,000 inc GST (which includes the final acceptance fee and Golden Rose nomination).

Final Acceptance

Final acceptance fee of \$30,000 inc GST to be paid before 9am, Tuesday prior to the race (final acceptance fee and any "late entry fee" paid for any horse rejected to be refunded).

First, second and final acceptances must be lodged when due or the Longines Golden Slipper entry will lapse.


2024 GOLDEN ROSE (G1)

\$1 Million Three-Year-Old Race

As an added incentive for owners, payment of the 2024 Longines Golden Slipper entry fee of \$440 will also mean your horse is automatically entered for another feature event which will be conducted by Australian Turf Club in the Spring of 2024.

Known as the \$1 million three-year-old Golden Rose (1400m). This exciting Group 1 race will be run at Rosehill Gardens in September 2024. Please note, your 2024 \$1 million three-year-old Golden Rose entry remains valid even if the Longines Golden Slipper nominations lapses at the first, second and/or final acceptance stage.

Full conditions and information relating to the \$1 million threeyear-old Golden Rose will be advertised in the normal manner.

TERMS & CONDITIONS

1. GENERAL CONDITIONS

- 1.1 The directors reserve the right to cancel the race and refund all moneys collected if in their opinion nominations are insufficient.
- 1.2 Entries for the race are subject to the Rules of Racing of the Board of Racing NSW by which the nominator agrees to be bound.
- 1.3 The Board of the Australian Turf Club reserve the right to decline any nomination and/or acceptance lodged with Australian Turf Club or Trainers Service Centre (TSC) from a licensed trainer with outstanding debts to the ATC from any Group or Listed race conducted by the ATC.
- 1.4 Conditions are subject to change. Australian Turf Club reserves the right to hold the late entry fee at \$150,000 should there be any reduction in prizemoney and as such reduced nomination and/or acceptance fees.
- 1.5 Trainers are responsible for the lodging of all horses under their care at each phase of the Longines Golden Slipper entries.

2. BALLOTING

- 2.1 Subject to clauses 2.3, 2.4 and 2.5, should it become necessary to reduce the number of acceptors, the excess horses shall be rejected, commencing with the horses which, at final acceptance time, have received the lowest amount of prizemoney.
- 2.2 For the purposes of this clause 2, "prizemoney" includes the advertised value of any trophies.
- 2.3 In determining prizemoney no account shall be taken of:
 - (a) Appearance monies, incentive payments, breeders' bonuses, starters' rebates or starters' bonuses:
 - (b) Any payment in connection with a race that was not available to all horses that were eligible to be nominated for the Golden Slipper Stakes unless otherwise specified in condition 2.3(e);
 - (c) the value of any stallion service won in connection with a race; or
 - (d) Prizemoney acquired by any horse in connection with horses bred, trained or sold in a particular region or state.
 - (e) To the winner only of the Inglis Millennium, an allocation of "Sydney minimum Listed race winning prizemoney" will be added to their nonrestricted prizemoney earnings for Golden Slipper order of entry purposes
- 2.4 The winners of the following races are exempt from the rejection provisions in clause 2.1: Silver Slipper Stakes, Sweet Embrace Stakes, Skyline Stakes, Reisling Stakes, Todman Stakes, Magic Night Stakes and Pago Pago Stakes
- 2.5 The directors, in their absolute discretion, may exempt any horse or horses from the rejection provisions in clause 2.1 and may select emergencies and determine their priority.
- 2.6 The final acceptance fee and any late entry fee paid for any horse rejected will be refunded.

3. WITHDRAWAL

3.1 Should any horse be accepted for and included in the field for this race, such horse (including emergencies offered a start) shall not be permitted to be withdrawn unless express permission be obtained from Racing NSW Stipendiary Stewards.
